Chairman Loomis opened the meeting at 10:00 a.m. Commissioner Patrick was absent. Commissioner Linaweaver made a motion to approve the agenda for March 5, 2013. Chairman Loomis seconded. **All voted aye.**

Commissioner Linaweaver made a motion to approve checks and claims for March 5, 2013 and payroll for pay period ending March 2, 2013. Chairman Loomis seconded. **All voted aye.**
