

MCPHERSON COUNTY COMMISSION MEETING MINUTES

Chairman Loomis opened the regular meeting at 9:00 a.m. One item was added to the agenda for September 30, 2013: Commissioner Linaweaver's report on the recent Public Health Workshop. Commissioner Patrick made a motion to approve the agenda as amended. Commissioner Linaweaver seconded. **All voted aye.**

No one spoke during Public Input at 9:00 a.m.

Commissioner Linaweaver made a motion to approve the minutes for September 23, 2013 as corrected. Commissioner Patrick seconded. **All voted aye.**

Commissioner Patrick made a motion to approve checks and claims for September 30, 2013 and payroll for pay period ending September 28, 2013. Commissioner Linaweaver seconded. **All voted aye.**

At 9:12 a.m. Tom Kramer, Public Works Director, joined the meeting with two items:

- A. A request to hire a Temporary Part-time Secretary to fill in at the Public Works Main Office for an employee during a short-term leave. Following discussion, it was a consensus among Commissioners to allow the request.
- B. A request to purchase a replacement vehicle/used truck. Following a review of bids, Commissioner Linaweaver made a motion to allow the purchase of a 2010 Silverado from Wallace Chevrolet in an amount not to exceed \$22,970.00. Commissioner Patrick seconded. **All voted aye.** It was a consensus among Commissioners to salvage the vehicle being replaced.

At 9:30 a.m. Janet Cagle, Community Corrections Director, joined the meeting to request signature on the Harvey/McPherson Counties Community Corrections Year End FY 2013 Outcomes to the Kansas Department of Corrections. Ms. Cagle reviewed the report and specified details and challenges for unsuccessful achievement of FY 2013 year end goals, as well as plans to increase the success rate in 2014. Commissioner Patrick made a motion for the Chairman to sign the report as requested. Commissioner Linaweaver seconded. **All voted aye.**

At 9:40 a.m., Commissioner Linaweaver gave a brief report on his September 26, 2013 Kansas Association of Local Health Departments (KALHD) County Commissioners Workshop in Wichita. He noted that the County Commissioners are to serve as the Board of Directors for their individual County Health Departments and will in the future, need to conduct periodic Board meetings.

Commissioner Patrick made a motion to approve adds and abates for September 27, 2013. Commissioner Linaweaver seconded. **All voted aye.**

Chairman Loomis presented a Personnel Change Notice (PCN) on behalf of the County Treasurer to promote Jessica Irving to a Clerk II (8B) in the Treasurer's Office effective October 13, 2013. Commissioner Patrick made a motion to approve the PCN as presented. Commissioner Linaweaver seconded. **All voted aye.**
