Chairman Loomis opened the regular meeting at 9:00 a.m. Commissioner Linaweaver made a motion to approve the agenda for March 2, 2015. Commissioner Becker seconded. **All voted aye.**

No one spoke during Public Input at 9:00 a.m.

Commissioner Becker made a motion to approve the minutes for February 23, 2015. Commissioner Linaweaver seconded. **All voted aye.**

Commissioner Becker made a motion to approve checks and claims, and witness checks for March 2, 2015, and payroll for pay period ending February 28, 2015. Commissioner Linaweaver seconded.

At 9:20 a.m., Tom Kramer joined the meeting with two (2) items:

- A. A request to approve the low bid from Malm Construction in the amount of \$532,889.41 for the 16th Avenue project. Following a review of bids, Commissioner Linaweaver made a motion to approve the bid as requested. Commissioner Becker seconded. **All voted aye.**
- B. A request to approve a Personnel Change Notice (PCN) to hire Leo Ritter as a Maintenance Worker I (9A), effective March 16, 2015, to fill a vacancy. Commissioner Linaweaver made a motion for the Chairman to sign the PCN as presented. Commissioner Becker seconded. **All voted aye.**

Commissioner Becker made a motion to approve adds and abates for February 27, 2015. Commissioner Linaweaver seconded. **All voted aye.**

Rick Witte, County Administrator/Financial Manager presented two (2) items on behalf of the Sheriff:

- A. A PCN to end the introductory status of Patty Ensz, Clerk I (6C), effective March 3, 2015. Commissioner Linaweaver made a motion for the Chairman to sign the PCN as presented. Commissioner Becker seconded. **All voted aye.**
- B. A request to approve the job re-evaluation of three (3) Corporal Correctional Officers from a grade 12 to grade 13 on the county pay scale. Commissioner Becker made a motion to approve the request. Commissioner Linaweaver seconded. **All voted aye.**
