- B. A request to approve the purchase of a logger for 911 Dispatch. Following a review of quotes, Commissioner Becker made a motion to approve the purchase from DSS Corp., including a prepaid 5 year maintenance warranty, in an amount not to exceed \$37,394.00. Commissioner Loomis seconded. **All voted aye.** Funding will be provided through donated dollars.

Commissioner Loomis made a motion to approve adds and abates for April 8, 2016. Commissioner Becker seconded. **All voted aye.**
