Commissioners Becker and Linaweaver - Present

Commissioner Loomis - Absent

Chairman Becker opened the regular meeting at 9:00 a.m. Commissioner Loomis was absent. Commissioner Linaweaver made a motion to approve the agenda for April 23, 2018. Chairman Becker seconded. **All voted aye.**

During Public Input at 9:00 a.m., Cindy Martens, Inman resident, joined the meeting to request additional information regarding conditions related to a recent zoning application.

Nicholas Reinecker, Inman resident also joined Public Input with concerning a recent Facebook posting by the McPherson County Sheriff's Office regarding the National Distracted Driving Awareness Month initiative.

Commissioner Linaweaver made a motion to approve the minutes for April 16, 2018. Chairman Becker seconded. **All voted aye.**

At 9:15 a.m., Tom Kramer, Public Works Director, joined the meeting with two (2) items:

- A. A request to approve a Personnel Change Notice (PCN) to hire Michael Hodges as a Part-time Seasonal Maintenance Worker (9A), effective April 25, 2018 to fill a vacancy. Commissioner Linaweaver made a motion for the Chairman to sign the PCN as presented. Chairman Becker seconded. **All voted aye.**
- B. A request for bid approval for a new sign truck. Following discussion, Commissioner Linaweaver made a motion to approve the quote from Midway Motors for a 2018 Dodge in an amount not to exceed \$40,127.00. Chairman Becker seconded. **All voted aye.**

Following discussion, Commissioner Linaweaver made a motion to sign all documents as presented. Chairman Becker seconded. **All voted aye.**

Commissioner Linaweaver made a motion for the Chairman to sign the PCN as presented. Chairman Becker seconded. **All voted aye.**

Commissioner Linaweaver made a motion to approve adds and abates for April 20, 2018. Chairman Becker seconded. **All voted aye.**

Commissioner Linaweaver made a motion for the Chairman to sign a PCN request to end the introductory period for Sergeant Koch (171), effective April 22, 2018 as presented. Chairman Becker seconded. **All voted aye.**
