Chairman Patrick opened the meeting at 10:00 a.m.

Commissioner Terry made a motion to approve the agenda for September 11, 2007. Commissioner Loomis seconded. **All voted aye.** 

No one spoke during Public Input at 10:00 a.m.

Commissioner Loomis made a motion to approve payroll for September 14, 2007. Commissioner Terry seconded. All voted aye.

Rick Witte, County Administrator, presented on behalf of the Sheriff's Department, a Personnel Change Notice (PCN) ending the probation status of Richard Langdon, Deputy Sheriff (15D) effective August 26, 2007. Commissioner Terry made a motion to approve the PCN as requested. Commissioner Loomis seconded. **All voted aye.** 

At 10:10 a.m., Brenda Becker, County Treasurer joined the meeting to present a PCN to fill a vacancy in the Treasurer's Department. Commissioner Terry made a motion to go to executive session for ten (10) minutes, from 10:10 a.m. to 10:20 a.m., including Mr. Witte, to discuss non-elected personnel in the Treasurer's Department. Commissioner Loomis seconded. All voted aye. No action was taken in executive session. Ms. Becker requested approval of the PCN to hire Kristi Monroe as a Bookkeeper/Clerk (9A) in the Treasurer's Department effective September 12, 2007.
